- **8. AMENDMENT.** This Agreement may be altered, modified or amended only by a written instrument, duly executed by both parties and stating that the alteration, modification or amendment is an addition to and subject to this Agreement.
- 9. WAIVER. No waiver of any provision of this Agreement shall be deemed, or shall constitute, a waiver of any other provision, whether or not similar, nor shall any waiver constitute a continuing waiver. No waiver shall be binding unless executed in writing by the party making the waiver.
- **10. ASSIGNMENT.** This Agreement shall not be assigned by either party without the express, written consent of the other party. Provided, however, that the District may assign its interest in this Agreement to any governmental agency which provides financing to the District.
